

# INVERKIP & WEMYSS BAY COMMUNITY COUNCIL

## Minutes of Business Meeting Held on Thursday 9<sup>th</sup> June 2005 In the Inverkip Hotel

Innes Nelson welcomed all present. At 7.30pm the meeting was opened

**3 Police matters:** PC Wilson advised the following calls had been received  
Disturbances 1, Assaults 4, thefts 2, thefts from vehicles 1, thefts of vehicles 4,  
housebreaking 2, suspect persons 4 counterfeit currency 1 vehicle escort 2, traffic  
miscellaneous 6, vehicles abandoned 6, RTA 3, Drunk drivers 4, vehicles pursuits 2,  
damage to property 11, alarms 4, fires 3, general complaints 28, assisting members of  
the public & other agencies 3, test address 1, missing persons 2, domestic incidents 2,  
miscellaneous calls 7.

There is a rise in the number of calls, which is encouraging that the members of the public are now advising the police of concerns they have.

### **4 Minutes: Matters Arising**

**Busses:** it was agreed to postpone this until the next meeting when Cllr Forbes should be in attendance.

**Minutes:** the minutes of the previous Business Meeting held on the 5<sup>th</sup> May 2005 were approved.

**5 Secretary's Report:** It was agreed that we would not attend the Kirkin of the Council on 19 June and the AGM of Inverclyde Community Care Forum on 23<sup>rd</sup> June. A letter had been received from J Wilson Ardgown Estates requesting a meeting regarding the forestry area behind Brigend. We had replied that no one was available but he could bring this issue up at this meeting.

**6 Treasurer's Report:** Cliff Lyons reported the Community Council's current balance stands at £910. On the next agenda we should raise the topic of the funding we currently have and proposals and expenses policy.

**7 Newsletter, Press matters and Website:** the closing date for the summer issue of the newsletter for Inverkip is 18.06.2005. The website is currently suffering as Robert & Scott are fully committed with work at the moment. They are looking for volunteers to help with the website and will give any necessary training.

24 Carron Rd Wemyss Bay - extension to dwelling house  
Hazelwood cottage Main St Inverkip - 2-storey extension  
Bankfoot Farm Inverkip - Change of use of store to bakery  
Gap site adjacent to Point Place Inverkip – re registered  
19 Castle Wemyss Dr Wemyss Bay - 2-storey side extension  
4 Etive Rd Wemyss Bay - 2-storey extension  
13 Redwing Dr Inverkip - erection of conservatory  
Square Wood (HMS Dalriada) Inverkip – change of use from vacant MOD site to Paintball Centre.

The Square Wood campaigners action group reported that they are given the impression from talking to residents and from their meetings that there may be in the region of 30-50 objections being submitted to planning in this regard. Their next meeting in the Pavilion will be 20.06.2005 @ 7.30pm.  
They had also met with David Cairns and were writing to all the councillors.

Confirmation had been received from Inverclyde Planning Dept in receipt of our objection to the Square Wood Proposal and The Inverclyde Local Plan first review proposed modifications.

**9 Date and time of next meeting:** the next meeting will be held a week later than usual on the **7<sup>th</sup> of July 2005**, 7.30pm at the Inverkip Hotel.

### **10 Any other business:**

**Mr G Scott Wemyss Bay:** Mr Scott advised that residents in Wemyss Bay who reside near the railway station and ferry terminal are disadvantaged by the parking regulation of on street parking. He has enquired to no avail to seek residents' permits for this area. He now requests that we help in this regard. He also advised that they have not yet received their recycling bins and when calling Inverclyde Council was advised that perhaps he was in North Ayrshire! Lorraine agreed to look into these matters.

**Kyles Association Update:** Jim McIntosh advised that they too had had an acknowledgement to their objection.

### **Inverclyde Council/Community Councils and Community Council Forum**

Ron Potter submitted a letter to the Community Council Forum and feedback from the Forum was that this had been distributed and give full discussion, but Ron has heard from another source that this was not the case. If this is correct Ron will write to The Forum advising that we withdraw from it.

**Primary School Visit:** as part of P5 current project 'our community' Innes & Lorraine had visited the class and given them an insight into the community council.
